(A) The objectives of award for innovative idea are:

- 3. To find technical solution for community / people problems under Swatch Bharat etc.
- 4. To facilitate linkage to technology for industrialization.
- 5. To encourage engineering graduates to take up entrepreneurship / self-sustainability / self-employability.

(B) Salient features of award for innovative idea are:

This award is announced only for student participants. The objective is to recognize and felicitate the talents amongst students of MITS with entrepreneurial spirit for innovative products, services or technologies of commercial potential that will benefit society at large.

- 1. The awardee of BIIE should propose an idea for starting and successfully managing one or more businesses in a way that demonstrates notable entrepreneurial characteristics. The awardee must demonstrate that his/ her idea for entrepreneurship is based on ethical practices and will promote indigenization for the national interest.
- 2. The award recognizes the achievements and qualities of students of MITS for starting and successfully managing one or more ventures that enriches humanity or addresses a social issue.
- 3. The awardee must demonstrate strong entrepreneurial mindset having creative approaches, willingness to take risk. The awardee must engage others, face ambiguity with enthusiasm, and lead others to further innovations.
- 4. Proposed ideas must encourage / help other fellow students to start a small business/ venture.
- 5. The award will encourage students at large scales for venturing into innovation, transformation of traditional practices into modern time high tech / intelligent products, services and diversified applications of technologies for social solutions.
